- ◆ Explain the prevalence, and impact of Perinatal Mood Disorders & Substance Use on maternal health, birth outcomes and infant development
- Discuss risk factors, including impact of poverty and trauma, for perinatal women
- → Identify 4 barriers to care that negatively impact perinatal women accessing treatment
- ◆ Describe how the Community-based Perinatal Support Model (CPSM) addresses all 4 barriers to care at individual, provider, system and policy levels
- ◆ Explain the sequence of interventions for the successful implementation of CPSM including effective screening protocols, triage and community referral protocols
- ◆ Describe the central role community partners have in developing the leadership team in the CPSM
- ◆ Identify 3 characteristics of community readiness to implement public health initiatives such as CPSM
